ARTICLES OF INCORPORATION

OF

HARRIS CHELAN MARINA CONDOMINIUM ASSOCIATION

The undersigned, for the purpose of forming a corporation under the nonprofit miscellaneous and mutual corporations act of the State of Washington, RCW 24.06, hereby adopts the following Articles of Incorporation.

ARTICLE I  
NAME

The name of this Corporation is HARRIS CHELAN MARINA CONDOMINIUM ASSOCIATION.

ARTICLE II  
DURATION

This Corporation has perpetual existence.

ARTICLE III  
PURPOSES

The purposes for which the corporation is organized is to establish a unit owners's association under the Washington Condominium Act, Chapter 64.34 R.C.W. The Association shall have the powers set forth under RCW 64.34.308 and amendments thereto.

ARTICLE IV  
MEMBERSHIP

The membership of the association shall consist exclusively of the unit owners of the Harris Chelan Marina Condominium. Other qualifications, rights and responsibilities of members and the manner of their admission and termination, are more fully set forth in the declaration of Harris Chelan Marina Condominium, which is incorporated herein by this reference.
